PATIENT AIRLIFT SERVICES' MISSION IS CARRIED OUT THROUGH DONATED FLIGHT SERVICES FROM PRIVATE PILOTS AND COMMERCIAL AIRLINES. DURING 2024, THE ORGANIZATION RECEIVED DONATED PILOT SERVICES VALUED AT \$4,009,243 AND FLIGHT TICKETS VALUED AT \$158,000. THE REVENUE AND EXPENSES FROM THESE SERVICES ARE NOT CAPTURED WITHIN THE FEDERAL FORM 990 IN ACCORDANCE WITH THE IRS INSTRUCTIONS. AS A RESULT OF THESE DONATED SERVICES, THE PERCENTAGE OF EXPENSES CLASSIFIED AS PROGRAM SERVICES, GENERAL AND ADMINISTRATIVE, AND FUNDRAISING EXPENSES IN THE AUDITED FINANCIAL STATEMENTS ARE 83%, 4%, AND 13%, RESPECTIVELY.
